Fund Objective

The Fund seeks to maintain a stable unit value of \$1.00; however, there can be no assurance the fund will always meet this objective.

Fund Composition

The Fund invests in high quality, short-term debt securities known as money market instruments. These securities include those issued by the US government and its agencies, corporations, banks, supranational organizations and sovereign issuers.

Investor Profile

Money market investments are ideal for short-term investors seeking a stable investment that provides interest income and liquidity. Over time, growth potential for money market securities is significantly lower than that of stocks and bonds. This fund is intended for investors seeking current income while preserving the value of their investment principal.

Fund Risks

Money market investments are considered low risk due to the financial strength of the issuers and the short-term maturity of the investments.
