Fund Objective

The Fund seeks to track the performance of the MSCI US IMI Real Estate 25/50 Index*. The MSCI US IMI Real Estate 25/50 Index* is designed to measure the performance of equity REIT securities.

Fund Composition

The Fund generally invests in REITs (Real Estate Investment Trusts) within the US in an attempt to parallel the investment performance of the MSCI US IMI Real Estate 25/50 Index *.

Investor Profile

Real estate securities may be appropriate for investors seeking real estate exposure and portfolio diversification. Real estate securities provide access to an asset class that has the potential for high dividend income and long-term capital growth. Real estate securities can be an important part of a diversified portfolio that includes other asset classes, such as bonds, U.S. stocks or foreign stocks.

Fund Risks

The performance of the Fund depends primarily on the changes in value of the underlying properties owned by securities in the Fund. In addition, the underlying portfolios may not be diversified, and therefore are subject to heavy cash flow dependency, self-liquidation and the possibility of failing to either qualify for tax-free pass-through of income under federal tax laws or to maintain their exemption from certain federal securities laws. Other risks include, but are not limited to, changes in general and local economic conditions, increases in property taxes, changes in tax laws and interest rates,

changes in the value of the underlying property owned by the trust and defaults by borrowers.
